

**Watercraft County Average Tax Rate
and Minimum Appraised Value Chart
For Calendar Year 2017**

Pursuant to K.S.A. 2016 Supp. 79-5501, the assessed value of 5% on any watercraft shall cause the annual tax bill to be not less than \$12. The 2016 county average tax rate, stated as a decimal multiplier per dollar of assessed valuation, is provided for determining the tax obligation during the 2017 tax year. The value listed in the Appraised Minimum Value column is for the 2017 tax year.
