Levy**, and is provided for use in determining the tax obligation during **2006** for motor vehicles taxable pursuant to K.S.A. Chapter 79, Article 51, and amendments thereto. K.S.A. 79-5105 (c) states in part "...and (5) as of November 1, 1998 such date in all years thereafter, such rate shall be computed without regard to the general property taxes levied by school districts pursuant to Senate Bill 171, Section 6 (3)(b), and amendments thereto."
